I remember getting sushi, meeting a co-worker of his, and hanging out at his mother's home. He was a wonderful host and it was apparent that he is a very considerate person. I flew home and we continued to date long distance. One of my favorite things about him was how he always had a smile on his face.

The next time we saw each other Erick came camping with my family in 2012. My parents found him to be extremely polite and he was very helpful around camp with what needed to be done. We went tubing down the local river each day, and had a blast. Erick was so grateful for the experience, he thanked my parents multiple times. He truly is such a kind and loving person.

Eventually the time came and I told him that I would still be his friend but that I felt I needed to see other people. I have to say I was surprised at how well he took that. He was agreeable and wanted for me what I felt was best. How rare for a guy to not get angry when getting dumped. We continued on our friendship, checking in with each other every few months, and even chatting to each other about who we were currently dating. He was always someone I could depend on to be a listening ear when I needed a friend.

After a rough breakup, and feeling the need to travel to clear my mind I went to visit Erick in New York City in 2013. We attended his band practice together and had fun exploring the city. It was to be able to spend time with someone I felt completely comfortable with while healing my broken heart. Erick and I have had countless conversations about the morality of self-defense and where that line lies. We even did some training while we were camping.
